1. <b>BOARFISH</b> - All FVs have a <b>5% by-catch</b> of the species as the directed fishery is now closed until September							
2. <b>HERRING</b> Area VII b, c & VIaS ( <b>North West Herring</b> ) - FVs under 20 m = <b>12 tons for TWO months ie 1st March to 30th April 2014</b>							
3. <b>HERRING</b> Area VII ghjk ( <b>Celtic Sea Herring</b> ) FVs under 20m Gillnet without an individual quota allocations - <b>CLOSED</b> and for FV less than 20 metres fishing for herring by means of Trawls - <b>CLOSED</b>							
4 For FVs appropriately permitted the following <b>DEEP SEA</b> Species are all <b>CLOSED: Red Seabream; Alfonsinos, Blue Ling &amp; Roundnose Grenadier.</b>							
5. <b>BLACK SCABBARD FISH</b> - Areas 6 & 7 = <b>0 Tonnes.</b>
