Please note that - from the 1st to 30th APRIL, 2013 :-							
1. BOARFISH - All FVs who do not have an individual allocation are entitled to a 5% by-catch of the species. Vessels with an individual allocation should have received same.							
2. HERRING VII b, c & VIaS (North West Herring) - CLOSED < 20m FVs - as members will be aware as part of his revised Herring Policy Document the Minister set aside 5% of the NW Herring Fishery to be utilised as an "Open" fishery for FVs who do not have an entitlement to fish for NW Herring. There is no booking in required and the quota will be managed by means of a monthly catch limit. It is open to all FVs <20m who do not have an entitlement and for April 2013 these FVs have a quota of 5 Tons of NW Herring to be taken in ICES Area VIIb,c; VIaS.							
3. For FVs appropriately permitted the following DEEP SEA Species are all CLOSED : Red Seabream; Alfonsinos, Blue Ling & Roundnose Grenadier.							
4. BLACK SCABBARD FISH - Areas 6 & 7 - 0 Tonnes .							
5. DEEP SEA SHARKS - Area 6 & 7 - CLOSED .							
6. SKATES AND RAYS - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.							
7. MACKEREL - Area VI, VII: FVs under 18m trawling without an individual quota allocations have been allocated - 5 Tons							
8. HERRING Area VII ghjk (Celtic Sea Herring) - Members should note on the advice of the CSHMAC there is no by-catch for Herring in the Celtic Sea for the month of April 2013 due to the fact the stock is spawning during this time therefore it is CLOSED .							
9. COD VIa: This fishery is now CLOSED and FVs are only entitled to have onboard a 1.5% by-catch per trip.							
10. MONK VI and VII - please note Monk for both Areas is a two month quota i.e. The quota shown is the combined quota available for April and May to vessels.
