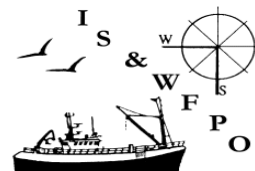

Please note the following for the period :

1st to 31st December 2017

- 1 **COD 6a :** This fishery is now CLOSED - FVs are only entitled to have onboard a 1.5% by-catch, per trip.
- 2 **COD VIIb-k :** Limit for boats using gillnets = **2 ton.**
- 3 **MONK 6 & 7 :** For Fishing Vessels in the "Monkfish Scheme" please check your Monk Authorisation
- 4 **SKATES & RAYS** Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- 5 **BOARFISH** Vessels with an individual vessel allocation should check their Authorisation. All other vessels have a 5% by-catch
- 6 **HERRING** **Area VII b, c & VIaS (North West Herring) - FVs under 20m is = 0 TON**
- 7 **HERRING** **Area VII-ghjk (Celtic Sea Herring) FVs under 20m, using Gillnet without an individual quota allocations = 3 Ton**
Area VII-ghjk (Celtic Sea Herring) FVs under 20m, using Trawls without an individual quota allocations = 5 Ton
- 8 **MACKEREL** Area VI,VII, VIIIa,b,d,e: FV's Less than 18m (except FVs fishing by hook & lines) without individual allocation = **5 Ton**
< 15m -Vessels fishing by means of hook & lines may retain on board or land up to **500kg** of Mackerel on any occasion but may not carry nets of < 80mm when availing of derogation.
