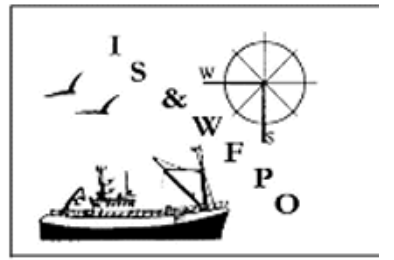
2 **Black Scabbardfish** Areas 6 & 7 - 0 Tonnes

3 **Deep Sea Sharks** Area 6 & 7 - CLOSED

4 **Skates & Rays** - Landings of the Common Skate, White Skate and Undulate Ray are prohibited however, there are special requirements in relation to Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.

5 **Edible & Spider Crab** - Fisheries Management Notice No. 32 of 2010 has the effect of RE-OPENING the Biologically Sensitive Area (BSA) for fishing for, transhipment or having on board Edible Crab or Spider Crab by Irish sea-fishing boats over 10metres with effect from the 19th October, 2010.

6 **PLAICE** Area 7fg has been **CLOSED** from 21st October, 2010.
