- 2 **Black Scabbardfish** Areas 6 & 7 - 0 Tonnes
- 3 **Deep Sea Sharks** Area 6 & 7 - CLOSED
- 4 **Skates & Rays** - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- 5 **Mackerel** - Area VI, VII: Vessels Under 18m trawling without an individual quota allocation have been allocated 2 tonnes
