<b>Please note that from 1st to 28th February, 2014</b>							
1. <b>BOARFISH</b> - All FVs who do not have an individual allocation are entitled to a <b>5% by-catch</b> of the species. FVs over 18m without a Boarfish allocation may land in any calendar year from 1st Jan to 15th Mar and 1st Sept to 31st Oct (2014) a quantity that does not exceed <b>450 tonnes</b> For vessels with an individual vessel allocation they should have received an Authorisation for the reallocation							
2. <b>HERRING</b> Area VII b, c & VIaS ( <b>North West Herring</b> ) - FVs under 20 m = <b>10 tons for two months - JANUARY/FEBRUARY 2014.</b>							
3. <b>HERRING</b> Area VII ghjk ( <b>Celtic Sea Herring</b> ) FVs under 20m Gillnet without an individual quota allocations - <b>CLOSED</b> and for FV less than 20 metres fishing for herring by means of Trawls - <b>CLOSED</b>							
4 For FVs appropriately permitted the following <b>DEEP SEA</b> Species are all <b>CLOSED: Red Seabream; Alfonsinos, Blue Ling &amp; Roundnose Grenadier.</b>							
5. <b>BLACK SCABBARDFISH</b> - Areas 6 & 7 = <b>0 Tonnes.</b>							
6 <b>DEEP SEA SHARKS</b> - Area 6 & 7 = <b>0 Tonnes</b>							
7. <b>SKATES AND RAYS</b> - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.							
8. <b>MACKEREL</b> - Area VI, VII: FVs under 18m trawling without an individual quota allocations have been allocated = <b>5 Tons</b>							
9. <b>COD VIa:</b> This fishery is now <b>CLOSED</b> and FVs are only entitled to have onboard a <b>1.5% by-catch</b> per trip.
