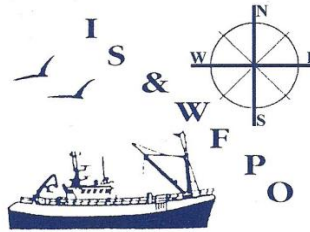

- 1 **BOARFISH:** All FVs who do not have an individual allocation are entitled to a 5% by-catch of the species.
- 2 **HERRING VIIb,c & VIaS (North West Herring) - 4 tons** <20m FVs- as members will be aware as part of his revised Herring Policy Document the Minister set aside 5% of the North West Herring fishery to be utilised as an "open" fishery for those vessels who do not have an entitlement to fish for North West Herring. There is no booking in required and the quota will be managed by means of a monthly catch limit. It is open to all vessels <20m who do not have an entitlement and for January 2013 these vessels have a quota of **10 tons** of North West Herring to be taken in ICES Area VIIb,c; VIaS
- 3 For vessels appropriately permitted:-  
the following DEEP SEA Species are all CLOSED - Red Seabream; Alfonsinos; Blue Ling and Roundnose Grenadier
- 4 **Black Scabbardfish Areas 6 & 7 - 0 Tonnes**
- 5 **Deep Sea Sharks Area 6 & 7 - CLOSED**
- 6 **SKATES & RAY** - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- 7 **MACKEREL** - Area VI, VII: Vessels under 18m trawling without an individual quota allocations have been allocated **4 tons**
- 8 **HERRING Area VII ghjk (Celtic Sea Herring)**  
Members should note on the advice of the CSHMAC there is **no by catch** for Herring in the Celtic Sea for the month of January, 2013 due to the fact the stock is spawning during this time therefore it is - CLOSED.
- 9 **COD VIa:** This fishery is now closed and vessels are only entitled to have onboard a 1.5% by catch per trip.
