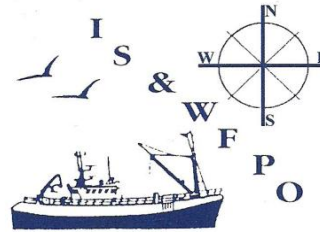

- Please note that from the **1st - to - 31st JULY, 2012.** for vessels appropriately permitted:-
the following DEEP SEA Species are all CLOSED - Red Seabream; Alfonsinos; Blue Ling and Roundnose Grenadier
- Black Scabbardfish** Areas 6 & 7 - 0 Tonnes
- Deep Sea Sharks** Area 6 & 7 - CLOSED
- Skates & Rays** - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- Mackerel** - Area VI, VII: Vessels under 18m trawling without an individual quota allocations have been allocated **- 5 tonnes**
- Porcupine Bank Nephrops** : Please note the 9 / 4.5 t Quota Allocation above is for THREE MONTHS i.e. May, June & July 2012 and vessels have the option to take the quota at any time during that 3 month period but once the quota is exhausted will be unable to fish for porcupine nephrops until August

- Cod VIa** : *this fishery is now closed and vessels are only entitled to have onboard a 1.5% by catch per trip*
- CELTIC SEA SELECTIVITY MEASURES** - for those FVs who implement Square Mesh Pan for JULY Quotas will be as follows:-
HADDOCK VIIb-k: 27t Scottish fly seines /18t / 9t and for **WHITING VIIb-k:** 60t / 30t.
- Boarfish:** All FVs who do not have an individual allocation are entitled to a 5% by-catch of the species.
FVs with an individual allocation once the target fishery closes on 15th March 2012 they will also have a 5% By-Catch.
