<b>1. BOARFISH</b> - All FVs who do not have an individual allocation are entitled to a <b>5% by-catch</b> of the species. Vessels with an individual allocation are not permitted to target Boarfish until 1st September and only have access to 5% by catch							
<b>2. HERRING</b> VII b, c & VIaS (North West Herring) - <b>CLOSED</b> < 20m FVs - as members will be aware as part of his revised Herring Policy Document the Minister set aside 5% of the NW Herring Fishery to be utilised as an "Open" fishery for FVs who do not have an entitlement to fish for NW Herring. There is no booking in required and the quota will be managed by means of a monthly catch limit. It is open to all FVs <20m who do not have an entitlement and for <b>May 2013</b> these FVs have a quota of <b>0 Tons</b> of NW Herring to be taken in ICES Area VIIb,c; VIaS.							
<b>3.</b> For FVs appropriately permitted the following <b>DEEP SEA</b> Species are all <b>CLOSED</b> : Red Seabream; Alfonsinos, Blue Ling & Roundnose Grenadier.							
<b>4. BLACK SCABBARDFISH</b> - Areas 6 & 7 - <b>0 Tonnes</b> .							
<b>5. DEEP SEA SHARKS</b> - Area 6 & 7 - <b>CLOSED</b> .							
<b>6. SKATES AND RAYS</b> - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.							
<b>7. MACKEREL</b> - Area VI, VII: FVs under 18m trawling without an individual quota allocations have been allocated - <b>5 Tons</b>							
<b>8. HERRING</b> Area VII ghjk (Celtic Sea Herring) - FVs under 20m trawling without an individual quota allocations have been allocated - <b>1 Tons</b>							
<b>9. COD VIa:</b> This fishery is now <b>CLOSED</b> and FVs are only entitled to have onboard a <b>1.5% by-catch</b> per trip.							
<b>10. MONK VI and VII</b> - please note Monk for both Areas is a <b>two month</b> quota i.e. The quota shown is the combined quota available for <b>April and May</b> to vessels.
