1. <b>BOARFISH</b> - All FVs who do not have an individual allocation are entitled to a <b>5% by-catch</b> of the species. FVs over 18m without an individual vessel allocation who had an allocation of 450tons to be caught between 1st Jan to 31st Oct 2013 - We await confirmation from DAFM as to whether there will be a reallocation and will advise members as soon as we know							
2. <b>HERRING</b> Area VII b, c & VIaS ( <b>North West Herring</b> ) - FVs under 20 m = <b>5 tons</b>							
3. <b>HERRING</b> Area VII ghjk ( <b>Celtic Sea Herring</b> ) FVs under 20m Gillnet without an individual quota allocations have been allocated = <b>3 Tons</b> and for FV less than 20 metres fishing for herring by means of Trawls have been allocated = <b>5 tonnes</b>							
4 For FVs appropriately permitted the following <b>DEEP SEA</b> Species are all <b>CLOSED</b> : <b>Red Seabream; Alfonsinos, Blue Ling &amp; Roundnose Grenadier.</b>							
5. <b>BLACK SCABBARD FISH</b> - Areas 6 & 7 = <b>0 Tonnes.</b>							
6 <b>DEEP SEA SHARKS</b> - Area 6 & 7 = <b>0 Tonnes</b>							
7. <b>SKATES AND RAYS</b> - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.							
8. <b>MACKEREL</b> - Area VI, VII: FVs under 18m trawling without an individual quota allocations have been allocated = <b>6 Tons</b>							
9. <b>COD VIa</b> : This fishery is now <b>CLOSED</b> and FVs are only entitled to have onboard a <b>1.5% by-catch</b> per trip.
