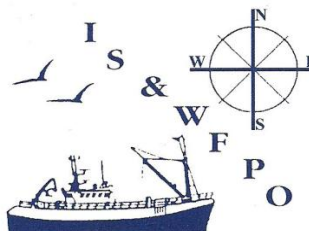

Please note that from the **1st to 31st October, 2012**

- BOARFISH:** All FVs who do not have an individual allocation are entitled to a 5% by-catch of the species. Fishing Vessels >18m without an individual Vessel allocation were allocated a quota of **400t** to be caught between 1st Jan to 15th March and 1st September to 31st October 2012.
- HERRING VIIb,c & VIaS (North West Herring) - 4 tons** <20m FVs- as members will be aware as part of his revised Herring Policy Document the Minister set aside 5% of the North West Herring fishery to be utilised as an "open" fishery for those vessels who do not have an entitlement to fish for North West Herring. There is no booking in required and the quota will be managed by means of a monthly catch limit. It is open to all vessels <20m who do not have an entitlement and for Oct these vessels have a quota of **4 tonnes** of North West Herring to be taken in ICES Area VIIb,c; VIaS
- For vessels appropriately permitted:-
the following **DEEP SEA** Species are all **CLOSED - Red Seabream; Alfonsinos; Blue Ling and Roundnose Grenadier**
- Black Scabbardfish** Areas 6 & 7 - 0 Tonnes
- Deep Sea Sharks** Area 6 & 7 - **CLOSED**
- SKATES & RAY** - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- MACKEREL** - Area VI, VII: Vessels under 18m trawling without an individual quota allocations have been allocated **6 tons**
- HERRING Area VII ghjk (Celtic Sea Herring)-2 tons < 20m FVs; if Gillnetters and 5 tonnes for <20m FVs if Trawlers.**
As members will be aware as part of his Revised Herring Policy Document the Minister set aside 5% of the Celtic Sea Herring fishery to be utilised as an "open" fishery for those vessels who do not have an entitlement to fish for Celtic Sea Herring. There is no booking in required and the quota will be managed by means of a monthly catch limit. It is open to all FVs < 20m who do not have an entitlement and for SEPT these FVs have a quota of **2 tonnes if Gillnetters OR 5 tonnes if Trawling.**
- COD VIa** : this fishery is now closed and vessels are only entitled to have onboard a 1.5% by catch per trip.
