Please note that from - 1st to 30th SEPTEMBER 2013

- BOARFISH** - All FVs who do not have an individual allocation are entitled to a **5% by-catch** of the species. Vessels with an individual allocation are not permitted to target Boarfish until 1st September and only have access to 5% by catch
- HERRING VII b, c & VIaS (North West Herring) - CLOSED** < 20m FVs - as members will be aware as part of his revised Herring Policy Document the Minister set aside 5% of the NW Herring Fishery to be utilised as an "Open" fishery for FVs who do not have an entitlement to fish for NW Herring. There is no booking in required and the quota will be managed by means of a monthly catch limit. It is open to all FVs <20m who do not have an entitlement and for **Sept., 2013** these FVs have a quota of **0 Tons** of NW Herring to be taken in ICES Area VIIb,c; VIaS.
- For FVs appropriately permitted the following **DEEP SEA** Species are all **CLOSED**: Red Seabream; Alfonsinos, Blue Ling & Roundnose Grenadier.
- BLACK SCABBARDFISH** - Areas 6 & 7 - **0 Tonnes**.
- DEEP SEA SHARKS** - Area 6 & 7 - **CLOSED**.
- SKATES AND RAYS** - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- MACKEREL** - Area VI, VII: FVs under 18m trawling without an individual quota allocations have been allocated - **6 Tons**
- HERRING** Area VII ghjk (**Celtic Sea Herring**) - FVs under 20m Trawl or Gillnet without an individual quota allocations have been allocated = **3 Tonnes** and for FV less than 20 metres fishing for herring by means of Trawls have been allocated - **5 tonnes**
- COD VIa**: This fishery is now **CLOSED** and FVs are only entitled to have onboard a **1.5% by-catch** per trip.
- Porcupine Bank Nephrops** - this fishery has been **temporarily** closed as there is only 36 tonnes remaining which is insufficient for one months fishery. A swap is being sought to obtain additional quota and if obtained the fishery will be re-opened.
