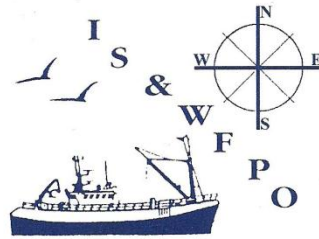

Please note from the **1st to 30th September 2015.**

- 1. BOARFISH** - As the fishery is closed at present all Fishing Vessels have a **5% by-catch** of the species.
- 2. HERRING Area VII b, c & VIaS (North West Herring)** - FVs under 20 m is **0 TONS**
- 3. HERRING Area VII ghjk (Celtic Sea Herring)** FVs under 20m Gillnet without an individual quota allocations **3 Ton**
and for FV less than 20 metres fishing for herring by means of Trawls **5 Ton**
- 4** For FVs appropriately permitted the following **DEEP SEA** Species are all **CLOSED: Red Seabream; Alfonsinos, Blue Ling & Roundnose Grenadier.**
- 5. BLACK SCABBARDFISH** - Areas 6 & 7 = **0 Tonnes.**
- 6 DEEP SEA SHARKS** - Area 6 & 7 = **0 Tonnes**
- 7. SKATES AND RAYS** - Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- 8. MACKEREL** Area VI, VII: FV under 18m (except those fishing by hook & lines) without an individual quota allocation have been allocated - **6 Tons**
< 15m - Vessels fishing by means of hooks and lines may retain on board or land up to **500kg** of Mackerel on any occasion but may not carry nets of < 80mm when availing of derogation.
- 9. COD VIa:** This fishery is now **CLOSED** and FVs are only entitled to have onboard a **1.5% by-catch** per trip.
- 10. MONK VI & VII** For Fishing Vessels in the Monkfish Scheme please check your Monk Authorisation
