**1st to 28th February, 2022**

- 1 COD : 6a and 6b - Allocation for this month
- 2 MONK 6 & 7 : This Scheme is suspended for now.
- 3 SKATES & RAYS Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- 4 BOARFISH Vessels with an individual vessel allocation should check their Authorisation. All other vessels have a 5% by-catch
- 5 HERRING **Area VII b, c & VIaS (North West Herring) - FVs under 20m is = 0 Ton**
- 6 MACKEREL Area VI,VII, VIIIa,b,d,e: FV's Less than 18m (except FVs fishing by hook & lines) without individual allocation = **2 Ton**  
<15m FVs fishing by means of hook & lines may retain on board or land up to 750kg of Mackerel on occasion but may not carry nets of < 80mm when availing of derogation.
7. SOLE f-g Please note that this will become a Choke Species if landings of even these small quantities continue.
