1st to 31st AUGUST, 2022

- 1 **COD :** 6a and 6b - Allocation for this month
- 2 **MONK 6 & 7 :** This Scheme is suspended for now.
- 3 **SKATES & RAYS** Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- 4 **BOARFISH** Vessels with an individual vessel allocation should check their Authorisation. All other vessels have a 5% by-catch
- 5 **HERRING** **Area VII b, c & VIaS (North West Herring)** - FVs under 20m is = **0 Ton**
- 6 **MACKEREL** Area VI,VII, VIIIa,b,d,e: FV's Less than 18m (except FVs fishing by hook & lines) without individual allocation = **2 Ton** <15m FVs fishing by means of hook & lines may land in the month **3 Ton**. For further information please see attached FMN No. 36 of 2022 and also FMN No. 32 of 2022.
7. **SOLE f-g** Please note that this will become a Choke Species if landings of even these small quantities continue.
