- COD :** 6a and 6b - Allocation for this month
- MONK 6 & 7 :** This Scheme is suspended for now.
- SKATES & RAYS** Landings of Common Skate, White Skate and Undulate Ray are prohibited and there are special requirements in relation to the reporting of landings of Cookoo Ray, Thorny Back Ray, Blondie Ray, Spotted Ray, Sandy Ray and Shagreen Ray.
- BOARFISH** Vessels with an individual vessel allocation should check their Authorisation. All other vessels have a 5% by-catch
- HERRING** Area VII b, c & VIaS (North West Herring) FVs > or = 15m & less than 20m = 0t and FVs less than 15m = 0t
- MACKEREL** Area VI,VII, VIIIa,b,d,e: FV's Less than 18m (except FVs fishing by hook & lines) without individual allocation = 6 Ton 5 Ton
Less than 15m FVs fishing by means of hook & lines may land in the month = 6 Ton
- SOLE f-g** Please note that this will become a Choke Species if landings of even these small quantities continue.
- POLLACK VII** If Quota Balancing - minimum 50kgs
